Dear CONTRIBUTOR:

This letter confirms our agreement with respect to one or more written works (each, including all accompanying graphics, photographs and text, a "Work" and, collectively, the "Works") to be created by you and published by Library Journals LLC, a wholly owned subsidiary of Media Source, Inc. ("LJLLC") during the Term (as defined below). This letter is effective from the date specified above until terminated by either of us by written notice to the other (the "Term"), and is applicable to all Works submitted by you to LJLLC during the Term whether or not described in writing. The terms of this letter with respect to rights granted during the Term will survive its termination.

Each Work shall be a "work made for hire" and, as such, LJLLC shall own all right, title and interest in and to the Works, including all copyrights and other intellectual property rights therein and all renewals and extensions thereof, in all formats and media, whether now known or hereafter developed, throughout the world in perpetuity. To the extent any of the Works are deemed not to be "works made for hire," you hereby assign to LJLLC all right, title and interest in and to the Works, including all copyrights and other intellectual property rights therein and all renewals and extensions thereof, throughout the world and in perpetuity. You also hereby assign to LJLLC all right, title and interest in and to each work of authorship (including accompanying graphics, photographs and text) submitted by you to LJLLC for publication prior to the Term, including all copyrights and other intellectual property rights therein and all renewals and extensions thereof, throughout the world and in perpetuity, and waive all moral rights you have therein. You further agree that LJLLC may use your name, likeness and/or biographical information in connection with the Works. You waive all moral rights you have in the Works.

In return for the rights granted herein, LJLLC agrees to consider your Works for publication, and if published to attribute authorship of the Works to you. Please note that by signing this letter, you acknowledge and agree that you are engaged as an independent contractor, that you are solely responsible for all income and self-employment taxes due as a result of any payments received under this letter and that you are not entitled to receive, and hereby waive in any event, any employee benefits offered to employees of LJLLC based on your engagement as an independent contractor. You may not assign this letter or any of your rights or obligations hereunder. This letter constitutes the entire agreement between us with respect to the subject matter hereof and may not be amended except in a writing signed by both parties.

You represent and warrant that (a) each Work (i) is your original work, (ii) has not been, and will not be, published prior to publication by LJLLC, (iii) has not been assigned, licensed or otherwise encumbered, (iv) is not libelous or defamatory and (v) does not violate any rights, including copyrights and rights of privacy or publicity, of any third party, and (b) you have obtained, or prior to delivery of each Work will obtain, all necessary releases, waivers and assignments, including those relating to models, likenesses and privacy, so that LJLLC may have exclusive ownership in and freely exploit the Works without further obligation or payment to any person or entity. You agree to indemnify, defend and hold harmless LJLLC and its affiliates against any claims, losses or expenses (including, without limitation, legal fees) arising out of any breach by you of any of your representations, warranties or obligations set forth in this letter.

Please sign this letter, retain a copy for your files and return the original to me. A signature on this agreement does not restrict you from incidental reprinting of the Work, using it in a course or conference proceeding, or including it in a book containing your works, provided a proper credit line is included in the following form: "Copyright © [year] Library Journals LLC, a wholly owned subsidiary of Media Source, Inc.
